PLACEMENT

I understand that I am auditioning for membership in the Harrisburg Symphony Youth Orchestras. I am prepared to play, if accepted, in whichever orchestra and seat I am placed. I understand that if I decline this place I may not re-audition until the 2019-20 season.

PUBLICITY RELEASE

The undersigned hereby consents and grants the Orchestra the worldwide right and license to use my child's name, photograph, likeness and any other words and symbols that identify the child in the advertising and promotion of the Orchestra in any medium without restrictions as to frequency.

ATTENDANCE POLICY

Each student is expected to be present and on time to all rehearsals. The HSYO Administrator keeps the roll book. **IF YOU ARE GOING TO MISS A REHEARSAL, YOU MUST LET THE HSYO ADMINISTRATOR KNOW IN ADVANCE.** Instructions for notifying the HSYO Administrator are included in the Handbook.

Because of the high level of musicianship required by the orchestras, attendance at concerts, pre-dress and dress rehearsals is mandatory. Students who are absent from a mandatory rehearsal may not be permitted to perform in the concert. Students are allowed no more than **two (2)** absences per concert rehearsal period. Students are tardy if they are not in their seats, tuned, with their music on the stands at the scheduled rehearsal time.

If a student misses a concert, they may become ineligible from participation in the program for the remainder of the season and may not be permitted to participate again until one full concert season has passed. If a student is excluded from a concert for attendance reasons, that student may remain in the program without penalty, provided they attend the concert as a member of the audience as a show of support for their fellow musicians.

Additional consequences for excessive absences, disruptive behavior, etc., may include being placed on probation, being seated at the back of a section and/or re-auditioning for the conductor, or other actions that may be appropriate.

TUITION POLICY

I agree to pay the Harrisburg Symphony Youth Orchestras for the participation of my child per the published tuition and other fees for the 2018-19 concert season and understand that full payment is expected at the first rehearsal. No musician will be permitted to play in the first concert if their tuition for the year is not paid in full.

I have read, understood, and agreed to the policies regarding General Liability, Medical Release, School Participation, Placement, Publicity, Attendance, Tuition, and the contents of the HSYO Handbook.
